Document Signing

Step 1: Click on "Adopt Signature"

Please select the "Adopt signature" button to type or draw your signature to be applied to the document.

Step 2: Select either Typed or Drawn signature style and click "Adopt Signature" to begin signing.

Provide your name by drawing with touch, mouse, or stylus.
